#### **MALAYSIAN HALAL CERTIFICATION CIRCULAR NUMBER 1 IN 2016**

#### LABELING OF RAW MATERIAL / PRODUCT SUPPLIED / PURCHASED IN BULK FROM INDUSTRY TO INDUSTRY

#### **PURPOSE**

This circular purposely to inform regarding the needs to label the raw materials/product supplied/purchased in bulk from industry to industry. The company that supply/purchase product in bulk should ensure there is label to ease traceability of raw materials/products Halal status.

#### BACKGROUND

2. Malaysia Halal certification auditing process very concern on traceability aspect on raw materials/ product Halal status that used by each Malaysia Halal Verification Certification (SPHM) applicant. Among the important traceability is raw materials/product that used in product processing must same as raw materials/ product that being announced through Malaysia Halal Certification application form. Therefore, raw materials/product labeling is very important for the purpose to identify Halal status and raw material/product manufacturer.

- 3. Auditing officer at Malaysian Islamic Development Department (JAKIM) and State Islamic Religious Departments (JAIN) used to face the problems when conduct field audits especially to do traceability on raw material/product Halal status that without any label particularly raw materials/product supplied/purchased in bulk. This situation becomes more complicated when the company/applicant fail to bring up any document to prove raw materials/product Halal status.
- 4. JAKIM and JAIN as the authority is being responsible in managing Malaysia Halal certification need to ensure each product certified comply each procedure that being termed. Therefore, the company/applicant need to ensure raw materials/product supplied/purchased in bulk or in the huge quantity need to have label to ease traceability on Halal status by JAKIM and JAIN Auditing Officers.

#### **IMPLEMENTATION**

#### The needs

- i. In accordance with the provisions of Clause 5.3 (i) Malaysian Halal Certification Procedure Manual (Third Revised) 2014 (MPPHM 2014), all products SPHM holder shall be clearly labeled on its packaging to avoid any confusion.
- ii. Therefore it is also, all raw materials/product supplied/purchased in bulk or in bulk quantity need to have label from manufacturing company to ease traceability when field audit process being conducted. The label should at least contain following information;
  - a. Halal logo;
  - b. Raw materials/product name;
  - c. Manufacturer name; and
  - d. Manufacturing date.

#### Involved Parties

- i. The circular applies to the following parties;
  - a. Manufacturer/ producer;
  - b. Distributor;
  - c. Repacker;
  - d. Contract manufacturer; and
  - e. Slaughtering house.

#### **EFFECTIVE DATE**

- 7. This circular effective from 2<sup>nd</sup> February 2016 and all companies/ Malaysia Halal Certification applicants need to comply and take note of the implementation of this circular.
- 8. The circular issued by the (2), the Trade Descriptions (Certification and Marking of Halal) 2011.
